

## **Odyssey Travel – Privacy Policy 2014**

This Privacy Policy discloses the privacy practices for Odysseytravel.com. This Privacy Policy applies solely to information collected by this website. It notifies you of the following:

1. What personal identifiable information is collected from you through the website, how it is used and with whom it may be shared.
2. What choices are available to you regarding the use of your data.
3. The security procedures in place to protect the misuse of your information.
4. How you can correct any inaccuracies in the information.

### **Information Collection, Use and Sharing**

We are the sole owners of the information collected on this site. We only have access to/collect information that you voluntarily give us via email or other direct contact from you. We will not sell or rent this information to anyone. We will use your information to respond to you, regarding the reason you contacted us. We will not share your information with any third party outside of our organization, other than as necessary to fulfill your request, e.g., mail you a brochure.

Unless you ask us not to, we may contact you via email in the future to tell you about specials, new products or services, or changes to this Privacy Policy.

On certain pages, such as New Adventures Women's Travel Club, a user is asked to complete a Member Interest Form, requiring certain information beyond an email address (mailing address and phone number). This information is used to contact you about the Women's Travel Club in which you expressed interest. At your option, you may also provide additional information about yourself, but it is not required.

We partner with a few third parties to provide specific services. When the user signs up for these services, we share names or other contact information that is necessary for the third parties to provide these services. These parties are not allowed to use personally identifiable information except for the purpose of providing these services.

This website contains links to other sites. Please be aware that we are not responsible for the content or privacy practices of such other sites. We encourage our users to be aware of when they leave our site, and to read the privacy statements of any other site that collects personally identifiable information. Some of our business partners may use cookies. However, we have no access to or control over these cookies, and they are not linked in any way to any personally identifiable information on our site.

### **Your Access to and Control of Information**

### **Security**
